SUBJECT: Coronavirus Update –State-wide Restrictions (Last Step)
ATTENTION: Club Managers

The Hon Premier Daniel Andrews has today announced the further lifting of restrictions in the “last step” of the Re-opening Roadmap. We have set out a relevant summary of the announced changes below for your information. For specific detail - please refer to the **attached** summary of easing restrictions.

Significantly, the announcement today included:

- From tonight - **11.59pm on 22 November 2020**, social gatherings and leaving home arrangements are to be amended as follows:
 - Face covering: mandatory indoors, unless an exemption applies. Include settings such as public transport, including when waiting at stations, ride shares, hospitals, care facilities and shopping.
 - Face masks not required outdoors except where physical distancing cannot be maintained, such as farmers’ markets and other outdoor retail.
 - Requirement to carry masks at all times.
 - Some industries are required to wear face coverings as part of their COVIDSafe Plan.
 - Public (space) gatherings: Up to 50 people can gather outdoors from any number of households, excludes infants under 12 months.
 - Private gatherings: up to 15 visitors, including dependants, **per day** can visit a household, either together or separately.
 - infants under 12 months are excluded from the visitor caps.
 - face masks recommended when physical distancing cannot be maintained.
 - keeping a record of visitors is advised
- From **30 November 2020**, workplaces currently working from home can return to the workplace – for up to 25% of their workforce per site, with standard workplace requirements including density limits continuing to apply. Businesses with fewer than 40 staff can have 10 staff on-site subject to density quotients. *Nb: Victorian Public Sector will remain under the setting of “if you can work from home, you must work from home”.*
- From **13 December 2020** up to 30 visitors, including dependants (infants under 12 months are excluded from the visitor caps), **per day** can visit a household, either together or separately.





Total venue capacity cannot exceed 300 people including both indoor and outdoor spaces.
<i>Entertainment and Leisure</i>	<ul style="list-style-type: none"> Retail betting venue: (No change) Electronic gaming: Cap of 150 patrons per venue with every second gaming machine disabled, group limit of 20 patrons, subject to a density quotient. <i>COVID Marshals are still required . The previous 90-minute patron dwell time and restrictions concerning trading hours have been dispensed with.</i>
